The Problem:

- Affiliate of the Gamaliel Foundation, which supplied false information to National CCHD about its relationship with the Fair Immigration Reform movement
- Member of Human Rights Atlanta, which promotes homosexual rights.
- Member of pro-abortion, pro-homosexual, Marxist Jobs With Justice

The Response:

After contacting the local diocese with initial findings in July, and providing additional information as they requested in August, American Life League never heard back.

Regarding the Gamaliel Foundation, on 8 August 2012, ALL received a letter from the Diocese of Pittsburgh that the Gamaliel Foundation claimed to have formally dissolved its membership in the Fair Immigration Reform Movement (FIRM) in May of 2010 because of FIRM's public call to include LGBT rights in immigration reform. As evidence, Gamaliel provided CCHD with a copy of a letter dated May 2010 addressed to FIRM, announcing its departure from FIRM as a member.

Further evidence discovered by American Life League proved that this claim was untrue. As the following evidence will illustrate, Gamaliel was not only a member of FIRM over a year and a half after the alleged departure letter from FIRM, but also that Gamaliel was nominated to FIRM's steering committee in December 2011.

ALL scheduled a meeting with the Executive Director of National CCHD to discuss the report. The meeting was subsequently cancelled by CCHD with the explanation, "we see no reason to meet at this time."

CCHD is developing additional structures and guidance to address in greater detail the ethical implications of these relationships and what is morally acceptable and what is not for CCHD funded groups.





Standing FIRM for All Families: FIRM calls for LGBT inclusion

In 2010, as a member of FIRM, the Gamaliel Foundation added its voice to FIRM's call for LGBT inclusion in immigration reform.

Today, the [Fair Immigration Reform Movement](#), a coalition of grassroots organizations, released the following statement calling for LGBT inclusion in comprehensive immigration reform:





This statement from FIRM makes abundantly clear the intention of the entire organization, and its members, to include homosexual activism in immigration reform.

FIRM Statement on Uniting American Families Act (UAFA)

We are moved by stories of bi-national couples who are fighting to keep their families together amidst a broken immigration system. Thousands of bi-national couples who identify as lesbian, gay, bisexual, transgender (LGBT) are at risk of separation. With no clear pathway towards legalization nor federal recognition of same-sex couples, these couples live constantly in a state of fear or exile.

We believe that keeping families together should be an integral part of comprehensive immigration reform. We believe that we strengthen our communities and our nation when we support the right of all families to stay together, including LGBT families.

This is why we support the Uniting American Families Act (UAFA). UAFA would add the term “permanent partner” to those sections of the Immigration and Naturalization Act that apply to legally married couples. Under UAFA, a “permanent partner” is an adult who is in a committed, intimate relationship with another adult in “which both parties intend a lifelong commitment.” This legislation would afford equal immigration benefits to permanent partnerships as exist for married heterosexuals.

While we believe that comprehensive immigration reform will benefit lesbian, gay, bisexual, and transgender (LGBT) immigrants, we recognize that the intersection of migration, sexuality and gender expression impact LGBT immigrants in disparate ways. Issues of detention, deportation and asylum are not only issues of dignity for LGBT immigrants, but often also issues of safety. We must remember these experiences in the struggle for immigration reform.

We need solidarity across movements in order to build the power necessary to achieve justice for all our communities. Such solidarity means that we recognize the multiple ways that people across lines of race, class, gender, sexuality, and ability experience immigration. We must work to build strategic relationships that lift up the most vulnerable among us in the struggle for just and humane immigration reform. This includes the lives and experiences of LGBT immigrants.

Marissa Graciosa, director of FIRM, says:

“There is power in our diversity, but we must honor that diversity. And it starts with keeping all families from all backgrounds together. This is why we support the Uniting American Families Act.”



GAMALIEL

In a letter dated 8 August 2012, the director of the CCHD for the Diocese of Pittsburgh reported that the Gamaliel Foundation claimed that it severed ties with the pro-homosexual Fair Immigration Reform Movement (FIRM) in May of 2010, BEFORE Gamaliel affiliate Pittsburgh Interfaith Impact Network (PIIN) received its 2011-2012 grant from the CCHD.

Further evidence illustrates that not only was the Gamaliel Foundation still a member of FIRM as recently as 9 December 2011, but the Gamaliel Foundation and FIRM both took measures to hide this relationship AFTER the CCHD asked the Gamaliel Foundation about its relationship with FIRM.

According to the letter from 8 August 2012:

“The Gamaliel Foundation, in compliance with Catholic teaching reflected in CCHD guidelines, **severed relations with the Fair Immigration Reform Movement (FIRM) in May 2010**.

...

According to Gamaliel, soon after they became aware of FIRM’s statement, the Foundation cut all ties to FIRM.”

What follows is solid evidence that illustrates the false nature of Gamaliel’s claim. In summary:

- The Gamaliel Foundation participated in a monthly FIRM membership conference call on 9 December 2011, one year and seven months AFTER it’s claim to have severed ties with FIRM.
- Gamaliel is listed on several FIRM documents as organizational members as well as members of the Executive Committee of FIRM in 2011, and these documents were hosted on **Gamaliel’s** website. These documents were uploaded under the heading “FIRM Strategy Session,” and were all dated 2011.
- Gamaliel is listed among members of FIRM in a March 2012 article on the Selma-to-Montgomery march.
- Both Gamaliel and FIRM deleted all the evidence we provided in our report from their websites AFTER the Diocese of Pittsburgh questioned the Gamaliel Foundation about its relationship with FIRM.

Immediately following the letter we received, this error message now appears where the 2011 membership map for FIRM appeared on Gamaliel's website on April 26, 2012, when American Life League captured the webpage.








Participants marching for civil rights from Selma to Montgomery, Alabama in 1965

The slides pertaining to the Gamaliel Foundation's participation in FIRM shows that Gamaliel was aware of FIRM's pro-homosexual position, and Gamaliel continued to maintain a relationship with FIRM anyway. But more to the point, Gamaliel falsely stated its relationship with FIRM after discovering this position in May of 2010.

 This has been an exciting month so far for LGBTQ rights. First, on February 7, a federal appeals court panel of three judges ruled that California's ban on same-sex marriage is unconstitutional, overturning Proposition 8, a ballot initiative launched in response to a state court's legalization of gay marriage. This is a great step toward restoring marriage equality in our most populous state. (Note: No new marriages can occur until the deadline passes for Prop 8 defenders to appeal to the full nine-member circuit court. Observers predict that the ruling will be appealed and the case will ultimately come before the Supreme Court.) Then, six days later, Governor Christine Gregoire signed into law a bill legalizing same sex marriage in Washington State.






NCRP's September 2010 document, "Strengthening Democracy, Increasing Opportunities," cheers for advancements among pro-abortion organizations and strongly supports same-sex marriage.

Reproductive Health – Thanks to the hard work of pro-choice organizations in the state, no anti-choice legislation has passed during the last ten years in the Montana legislature, despite the introduction of dozens of anti-choice bills every biennial session. MWV added to the effort by helping present reproductive choice within a broader framework of issues affecting the health and well-being of women and families. The MWV Coalition also provides a vehicle for other women’s organizations (such as economic justice and domestic violence organizations) to support pro-choice legislation, which helps prevent alienation of pro-choice issues. In 2005, Montana passed the state’s first pro-choice bill, protecting patient access to clinics with a “buffer zone” from protestors. MWV also worked with member organizations NARAL and Planned Parenthood on a successful “decline to sign” campaign against a “life begins at conception” ballot initiative that failed to qualify for the ballot in 2008 and 2010. MWV and its member organizations have also worked hard to promote a proactive reproductive healthcare agenda which includes increasing access to comprehensive sex education and affordable birth control.

Peppered throughout the document are statements of support for same-sex marriage.

Basic Rights Oregon successfully defended the nondiscrimination and domestic partnership laws from going to the ballot for repeal, reducing the likelihood of a national wave of similar ballot measures over the next decade. These victories resulted from a compre-

The Oregon Family Fairness Act created domestic partnerships that grant to same-sex couples many of the rights, benefits and responsibilities that are granted to opposite sex couples who marry under state law. By passing this law, Oregon became the first state in the nation to grant comprehensive state-based relationship recognition to same-sex couples under the confines of a constitutional amendment banning marriage equality. In the past, same-sex couples had to prepare legal

The Equality State Policy Center and its member organization Wyoming Equality have fended off Wyoming efforts to prohibit recognition of same-sex marriages from other states. According to ESPC Director

In 2004, Basic Rights Oregon worked hard to defeat a ballot measure excluding LGBTQ residents from marriage rights. While the exclusionary measure did pass, and the loss was very difficult, the organization built a significant infrastructure in the process that enabled major victories in the next several years.

NCRP's newsletter for the Summer of 2010 promoted the Global Fund for Women's work in legalizing abortion and same-sex marriage.




Funding Controversial and Cutting-edge Work

The Global Fund has been willing to fund groups working in remote and politically unstable parts of the world — tiny island nations in Oceania, in Gaza and the West Bank, in Afghanistan under the Taliban, and equally willing to extend its support for groups working on controversial issues — legalizing abortion, standing up for the rights of lesbians and transgender people, or defending the rights of sex workers to be treated with dignity and



respect. Because of our deep ties to the women's movements, we often are able to infuse critical support to groups that are most invisible and marginalized, such as a group of small lesbian organizations in Mexico City. These groups organized lesbian marches for several consecutive years, and they grew in numbers each year and developed a solidarity network of indigenous people, youth and women with disabilities. Their persistent work has shifted cultural awareness and understanding so significantly that last year, Mexico City became one of the first cities in the world to legalize gay marriage.

NCRP recently celebrated the LGBTQ Funders' "40 years of LGBTQ Grantmaking."







The Center's *Progress and Perils* served as the impetus: It reported that women are less engaged in women's issues and that reproductive health/abortion is not a top priority issue for women. 
Our Challenge

We face challenging times, but it is an opportune moment in history to reevaluate our work, our movement, our values, and how we choose to work with one another. The NWM meetings forced us to look not only at the state of the movement but to look inward to the kinds of values and principles that developed within our organizations, and whether those values build or burden the movement.



Having published this article for its own newsletter, NCRP is using its organizational position to support and spread abortion as a "right." As a paying member, the Gamaliel Foundation is directly funding this effort.

Similar to our work with funders within the NWM Initiative, I ask foundations that fund women's and reproductive rights organizations to seriously consider whether their support truly sustains organizations for the long haul and whether their support reaches new voices and communities. NCRP's Spring 2003 newsletter was a screed against Dr. Dobson's Focus on the Family because the organization stood against birth control, homosexuality and abortion.

Dobson and other leaders of the well-funded political right for the past 20 years have advanced public policies that threaten freedom and tear at the fabric of our democracy. In opposing stem cell research, they block promising medical advances that could spare millions of American families from the tragedies of Alzheimer's disease, diabetes and heart disease. In rejecting effective family planning and HIV-prevention efforts, they put countless vulnerable Americans and their families at risk. Reasonable moderate, progressive and conservative people of faith are slowly advancing a healthy vision of family values that encompasses true compassion, civility, mutual respect for human dignity and support for equal rights. Organizations concerned with equal rights for gay, lesbian, bisexual and transgender Americans, including the Human Rights Campaign and the National Gay and Lesbian Task Force, have built cooperative partnerships with religious leaders, even as their denominations still struggle internally over full inclusion of gay and lesbian congregants and clergy. Funders, in particular the Gill Foundation, have provided indispensable support to these partnerships, significantly strengthening them organizationally and increasing their effectiveness.







Kentucky JwJ announced a “victory over homophobia” in JwJ’s 2007 newsletter. Kentucky JwJ stated its support for the “Fairness Campaign” in the article.

KY JwJ Supports Victory Against Sexual Orientation Discrimination

Shortly after midnight on Tuesday, November 27th, the Jefferson County Board of Education voted by a 4-3 margin to add sexual orientation, but not gender identity, to its non-discrimination and harassment policies. This was a definite victory over homophobia, and for school equality, as anti-Fairness forces had mobilized in full force against this measure. It was not, however, a victory for full equality, as JCPS employees are still at risk for harassment and discrimination based on gender identity...for now.

Like many organizations, Kentucky Jobs With Justice spoke up with the Fairness Campaign in its time of need! KY JwJ's Coordinator spoke at the November 12th Board meeting and sent a GetActive alert to all of our Louisville members asking them to call their Board Member or to send them an e mail.

Steve **Imhoff**, Larry **Hujo**, Debbie **Wesslund**, and Joe **Hardesty** all voted to expand protection, and should be applauded for their courage and commitment to justice. Sadly, Ann Elmore, Carol Ann Haddad, and Linda Duncan all failed to understand just how important this issue is and voted against protecting our community's educators and the basic human rights of working people.

The Campaign for School Equality continues! KY JwJ will continue to stand by the Fairness Campaign to win protection for all JCPS workers from discrimination and harassment based on gender identity and to amend the Student Code of Conduct to guarantee the same protections for all students in the JCPS school system.




