

Mass-Care produced an open letter to the Democratic Party of Massachusetts, complaining that the party platform dropped reference to "stem-cell research and the embodiment of marriage equality in the constitution."

Dear Massachusetts Democratic Party Delegates,

This year the Party's Platform Committee has proposed a dramatic rewrite of the state Platform, eliminating almost all references to particular policies, replacing them instead with references to broad goals and values. We write to you as fellow delegates, as city and town committee activists, as members of advocacy organizations, and as concerned Democrats who are working to make these values a reality on the ground, to <u>urge that you oppose watering down the platform at the upcoming State Convention.</u>



The word "immigrant" has been expunged from the newly proposed document, and along with it support for immigrants' right to organize into unions, equal rights for undocumented workers, prevailing wage policies, indexing the minimum wage to inflation, and no public funds for union busting. The new platform also drops any reference to national war spending, opposition to the Patriot Act, affirmative action, American Indian tribal sovereignty, stem-cell research and the embodiment of marriage equality in the constitution.



One of Mass-Care's complaints, and why it calls for single-payer health care is because birth control costs are too high.



Gender Disparities in Access to Care

Private, employer-based health insurance in the United States is particularly hard on women. Women require more medical services than men, primarily due to reproductive and preventative care, including mammographies, pap smears and birth control. Because of this, they spend much more on health care annually: In 2006, 63% of women spent more than \$1,050 out-of-pocket for health care, compared to only 46% of men. In addition, women are 15% less

Frequently Asked Questions

What is single payer?

A single payer insurance system for Massachusetts would be like an improved and expanded Medicare plan for everyone in the state, guaranteeing access to comprehensive health care for all residents. The "single payer" would be a public agency that pays for health care, but the delivery of care would remain largely private. <u>Under this system</u>, all Massachusetts residents would be covered for all medically necessary services including: doctor, hospital, preventative, long-term care, mental health, <u>reproductive health care</u>, dental, vision, prescription drug and medical supply costs.

Kentucky JwJ announced a "victory over homophobia" in JwJ's 2007 newsletter. Kentucky JwJ stated its support for the "Fairness Campaign" in the article.

KY JwJ Supports Victory Against Sexual Orientation Discrimination

Shortly after midnight on Tuesday, November 27th, the Jefferson County Board of Education voted by a 4-3 margin to add sexual orientation, but not gender identity, to its non-discrimination and harassment policies. This was a definite victory over homophobia, and for school equality, as anti-Fairness forces had mobilized in full force against this measure. It was not, however, a victory for full equality, as JCPS employees are still at risk for harassment and discrimination based on gender identity...for now.

Like many organizations, Kentucky Jobs With Justice spoke up with the Fairness Campaign in its time of need! KY JwJ's Coordinator spoke at the November 12th Board meeting and sent a GetActive alert to all of our Louisville members asking them to call their Board Member or to send them an e mail.

Steve Imhoff, Larry Hujo, Debbie Wesslund, and Joe Hardesty all voted to expand protection, and should be applauded for their courage and commitment to justice. Sadly, Ann Elmore, Carol Ann Haddad, and Linda Duncan all failed to understand just how important this issue is and voted against protecting our community's educators and the basic human rights of working people.

The Campaign for School Equality continues! KY JwJ will continue to stand by the Fairness Campaign to win protection for all JCPS workers from discrimination and harassment based on gender identity and to amend the Student Code of Conduct to guarantee the same protections for all students in the JCPS school system.
