The Latino Union has been involved in the push for abortion, homosexuality, Marxism and a member of several pro-abortion, pro-LGBTQ organizations for a very long time. In 2012, the Reform CCHD Now coalition put together a [damning report on the Latino Union](#) regarding these activities, including its memberships in Jobs with Justice and the National Day Laborer Organizing Network, and the Latino Union has never lost a dime of funding for it.

Membership in those two organizations alone oblige the CCHD to refuse funding to the Latino Union, and yet the funding continues. Now, we have discovered that the current executive director of the CCHD is a member of a local Socialist Political organization and Latino Union's memberships have expanded to two other organizations that are just as bad, if not worse, than the previous two.

In it we discussed the historical changes of the international solidarity movements for the independence of Puerto Rico and what those changes represent. Earrings to our video."



In [August of 2016](#), MST posted a picture of Rivera giving a talk, saying:

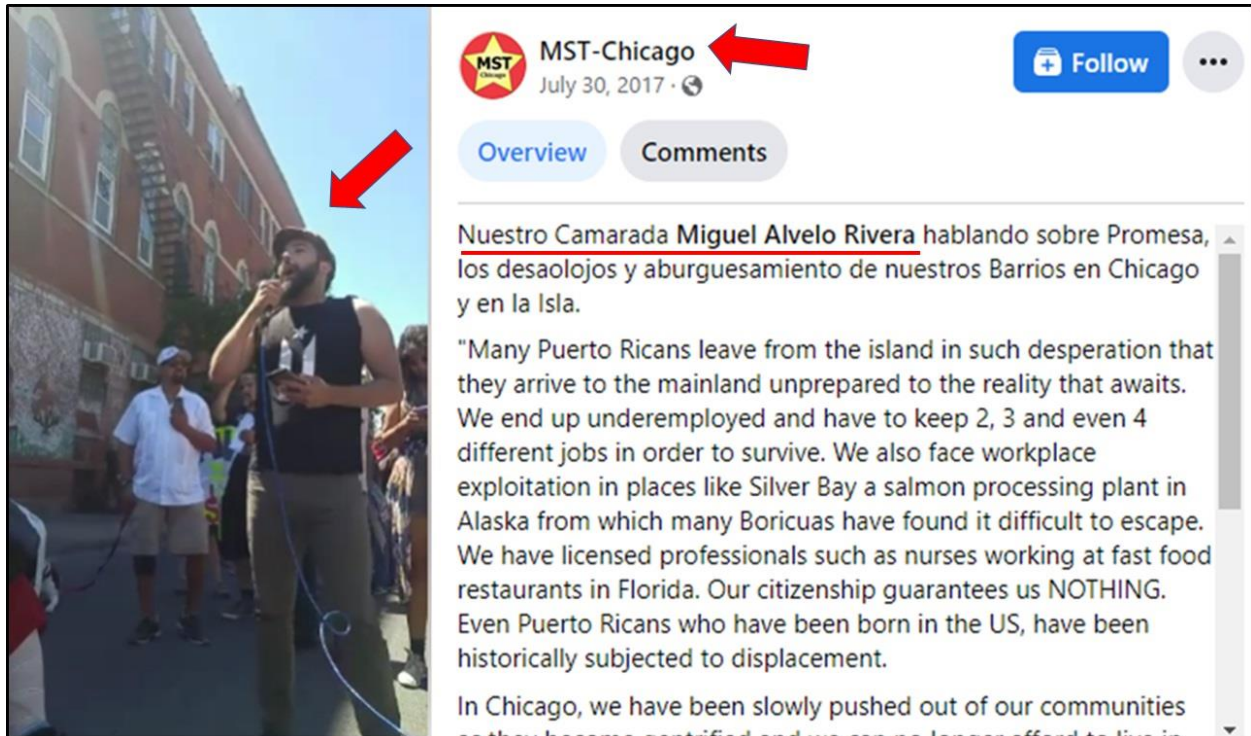

On [July 30, 2017](#), Rivera is identified as "Comrade" by MST, which says: "Our Comrade Miguel Alvelo Rivera speaking about Promise, the evictions and gentrification of our neighborhoods in Chicago and on the Island."



On [Sept 20, 2017](#), Rivera posted on his own facebook page, "Long live free and socialist Puerto Rico."



It's important to note just how Marxist MST-Chicago truly is. Given Rivera's membership in MST and his leadership at the Latino Union, there is zero doubt that the Latino Union is being run by a committed Marxist.

For instance, MST [posted this picture of a little girl](#) hugging Lenin's book titled "The Emancipation of Women," with the words below saying, "The Revolution Begins at Home."



In this post, MST published a picture of Karl Marx with the words, "For this Christmas we do not want gifts, we want the means of production."



There are dozens of pictures and posts along these lines, but this suffices to make the point; MST is a Revolutionary and Marxist organization, and the head of the Latino Union is a member.

### **Latino Union is a member of several Pro-abortion, Pro-LGBT, Marxist Organizations**

The CCHD absolutely forbids organizations from membership in organizations acting against Catholic teaching. In an [FAQ on the USCCB website](#), the CCHD directly answers the question about whether grantees may be members of coalitions that oppose Catholic teachings. In answer, the CCHD firmly stated, "CCHD will not fund groups that are knowingly members of coalitions that have as part of their organizational purpose or coalition agenda, positions or actions that contradict fundamental Catholic moral and social teaching."


**What about participation in coalitions for a good purpose, like better wages or housing, that include groups acting against Catholic values on other issues?**

CCHD encourages groups to work across geographical, racial, ethnic, economic, and ideological lines to overcome poverty and advance the common good. However, CCHD will not fund groups that are knowingly members of coalitions that have as part of their organizational purpose or coalition agenda, positions or actions that contradict fundamental Catholic moral and social teaching (e.g. promotion or support of abortion, same-sex marriage, euthanasia, racism, as well as the use of the death penalty punitive measures toward immigrants, etc.). Prohibited activities include participation in or endorsing actions that promote legislation, and ballot initiatives (including voter guides and other written materials) that contradict Catholic moral or social teaching.

Despite this requirement, however, the Latino Union is a member of four organizations that are actively promotion abortion, homosexual and transgender ideologies, and Marxism: Jobs with Justice, the National Domestic Workers Alliance, the National Day Laborer Organizing Network and the Hispanic Federation.

# Jobs With Justice Slams ‘Reprehensible’ U.S. Supreme Court Decisions for Delivering a Major Blow to Working People

Washington, DC – Today Jobs With Justice slammed a series of reprehensible rulings from the U.S. Supreme Court this week that dealt a major blow to working people, including its blockbuster decision overturning *Roe v. Wade*. Erica Smiley, Executive Director of Jobs With Justice, stated the following:

“For the first time in history, the US Supreme Court removed a bedrock constitutional right, overturning *Roe v. Wade* and letting states institute complete bans on abortion.

“Jobs With Justice stands with working women around the country in condemning this radical assault on our rights and settled law. We also join the call for government leaders, corporate CEOs, and workers everywhere to do everything in their power to protect women’s rights to control their bodies and access necessary health care, including the ability to terminate a pregnancy.

In August of 2020, JwJ’s executive director, [Erica Smiley issued a statement](#) on the JwJ website regarding Joe Biden’s pick of Kamala Harris as his running mate, demanding that “the campaign must fight for access to reproductive health care, including abortion.”

## Erica Smiley, Executive Director, Jobs With Justice

“The COVID-19 pandemic has exposed longstanding structural inequities in our economy and workplace practices. Alongside VP candidate Kamala Harris, Joe Biden’s campaign must present their plans to ensure decent working conditions, fair wages, and an active voice for workers in decision-making. Additionally, given that nearly half of the US labor force—women—also manage multiple jobs on top of domestic labor, the campaign must fight for access to reproductive health care, including abortion, so that all working people and their families can make sustainable economic choices and live with dignity.”

Also in 2020, JwJ announced that it was joining a massive abortion effort called All Above All. [In an article for Women’s Media Center](#), JwJ executive director Erica Smiley was interviewed. She stated in this article, “Demanding abortion coverage and overturning Hyde is step one for us,” Smiley says, also noting that abortion coverage advances racial justice too. “That’s essential for women of color to actually be supported and get the resources they need to thrive.”

The article goes on to state, “Jobs with Justice’s key demands of the Biden administration and Congress, as both try to move forward on a relief package, include lifting the Hyde Amendment, a policy that restricts Medicaid coverage of abortion care.”

As Congress works to pass President Biden’s \$1.9 trillion COVID stimulus bill, leaders of the movement for workers’ rights haven’t just been fighting for a \$15 minimum wage and other key protections for unions and low-wage workers to be included in the package. They’re also urgently fighting for coverage of reproductive health care, amid a pandemic that has exacerbated barriers to abortion and birth control — especially for low-wage workers, who are more likely to be women of color.

The inextricable intersections between economic justice and reproductive

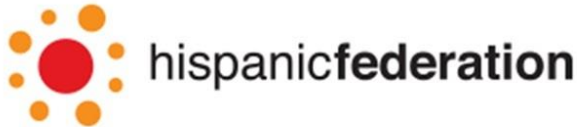

The Hispanic Federation is not only pro-abortion, but its promotion of homosexuality and transgenderism borders on the pornographic.

On the Hispanic Federation's website is a list of advocacy programs engaged in by the Federation itself. One of those program areas is "health," wherein the Hispanic Federation states its goal to advocate for sexual and reproductive health "and rights.":

"Hispanic Federation has taken a national leadership role in raising awareness of Latino health disparities and promoting strategies to improve Latino health as well as increasing Latinos' access to affordable and quality healthcare.

Our portfolio is anchored by three central goals:

- - [Increasing access to healthcare](#)
  - [Supporting healthy lifestyles](#)
  - [Advocating for sexual and reproductive health and rights](#)

Scrolling down to the "Advocating for Sexual and Reproductive Health and Rights" portion of this page reveals that Hispanic Federation is explicitly working to promote unrestricted access to abortion, contraception, and comprehensive sex education.

## Advocating for Sexual and Reproductive Health and Rights

Reproductive health and rights is critical to the Latino community. Unfortunately, a lack of access to quality reproductive healthcare and lack of knowledge concerning sexual and reproductive rights means that Latinos are more likely to experience reproductive cancers, unplanned pregnancies, sexual violence and sexually transmitted disease than other Americans. Hispanic Federation works to make sure that all Latinos have access to quality sexual and reproductive health services.

But our work extends beyond increasing access to healthcare. Our Reproductive Justice initiative is designed to challenge and change many of the structural issues that make it difficult for Latinos to take control over their reproductive health through raising awareness and advocating at the local, state and national level for policies which promote sexual and reproductive health and rights.

Hispanic Federation is also a partner in the I Am/Yo Soy campaign, which works to end silence about sex education, birth control, abortion, and young parenting. The campaign shows how understanding sexuality and reproductive health can make Latinos and their families more empowered, healthier and stronger. The campaign builds on a number of key principles:

- Decisions about birth control, abortion and parenting are ours to make
- Families need more access to health care and education, not less
- The need to speak out against attempts to restrict sexuality education or reproductive health options in our community
- The need to build tools and education to help us communicate with our young people openly about how to grow up safe and healthy

The Hispanic Federation's advocacy for abortion goes back to at least 2016, when it published an article titled "[Latina Reproductive Health on Trial](#)." In the article, Hispanic Federation complained about medical quality standards being imposed on abortion facilities, saying that such legislation would "make it impossible to secure an abortion in" Texas. The president of the Hispanic Federation, José Calderón, commented on the attempt by Texas to restrict access to abortion, saying:

“The fact is that anti-choice activists are getting bolder and savvier in their attempts to curtail how women control their bodies ... Reproductive health is critical to our families and communities and we can’t allow legislatures to circumvent the law of the land.”

## Latina Reproductive Health on Trial

In 2013, the Texas legislature attempted to do an end-run around protections of women's reproductive rights by passing a law, H.B. 2, which places onerous restrictions of individual medical providers and health clinics. Texas lawmakers, as the Center for Reproductive Rights has explained, required that physicians who provide abortion services to obtain admitting privileges at local hospitals within 30 miles away of the clinic in which they see patients and also mandated that every health care facility offering abortion care must meet building specifications that essentially turn these outposts of community healthcare into "mini-hospitals." Under the guise of protecting patients and ensuring quality medical care, the legislators attempted to make it impossible to secure an abortion in the state. Should the law go into effect, estimates are that 75 percent of abortion providers in Texas would have to close their doors.

The impact of H.B. 2 on Texas' Latinas would be enormous. As the National Latina Institute for Reproductive Health (NLIRH) noted in its amicus brief with the Supreme Court, Latinas in Texas already face significant barriers to quality health care including lack of insurance, poverty, and access reliable to public transportation. The Texas law would make reproductive health care virtually inaccessible to Latinas throughout Texas but especially in the already underserved communities along the Texas-Mexico border.

Hispanic Federation has been keeping a close eye on the Whole Women's Health v. Hellerstad. The implications of the law stretch far beyond the Lone Star State and threaten women's health access throughout the United States. As part of the national I Am/Yo Soy campaign, Hispanic Federation has been raising awareness in Latino communities about the importance of protecting reproductive freedoms.

"The fact is that anti-choice activists are getting bolder and savvier in their attempts to curtail how women control their bodies," said Hispanic Federation President José Calderón. "Part of the reason we joined with the NLIRH and our other partners in the I Am/Yo Soy campaign was that we realized that protecting reproductive rights is a national issue and that the issues that affect Latinas in Texas today might very well be something that we have to address in Florida or California tomorrow. Reproductive health is critical to our families and communities and we can't allow legislatures to circumvent the law of the land."

In [May of 2022](#), the Hispanic Federation directly called on Congress to pass pro-abortion legislation. In the press release, the current president and CEO of the Hispanic Federation said:

"Hispanic Federation calls on Congress to pass legislation that will uphold our reproductive rights and represent the majority of American voters who believe that access to reproductive abortion healthcare should be legal. If *Roe v. Wade* is overturned, it will cause immeasurable damage to our civil rights. ... Hispanic Federation will continue to fight for access to comprehensive reproductive care with dignity and justice for everyone in our communities, regardless of what the Supreme Court decides."

## **Hispanic Federation Calls on Congress to Pass Abortion Rights Legislation**

**WASHINGTON** – A **draft opinion** from Supreme Court Justice Samuel Alito leaked yesterday stating that a majority of Supreme Court justices could overturn *Roe v. Wade* - a 1973 Supreme Court decision that made abortion a constitutional right across the country. Hispanic Federation urgently calls on Congress to act swiftly in passing federal legislation that will protect the right to abortion. If *Roe v. Wade* is overturned, it will end the nearly 50 years of federal constitutional protection of abortion rights, making it one of the biggest restrictions and reversals to reproductive rights. If issued, the pending decision will disproportionately impact Latinos, people of color, low-income, and LGBTQ+ individuals, imposing grave risks to health and setting a dangerous precedent for overturning other civil rights protections.

On [June 24, 2022](#), the day the Supreme Court overturned *Roe v. Wade*, the Hispanic Federation "Vowed" to fight for women's "right" to have an abortion. Stated in the first paragraph of the press release the "Hispanic Federation condemns this decision and once again calls on Congress to immediately pass federal protections for abortion rights." The opening line of Hispanic Federation president Frankie Miranda's statement declares:

"We are outraged by the Supreme Court's decision today, which ended nearly 50 years of federal constitutional protections for abortion rights."

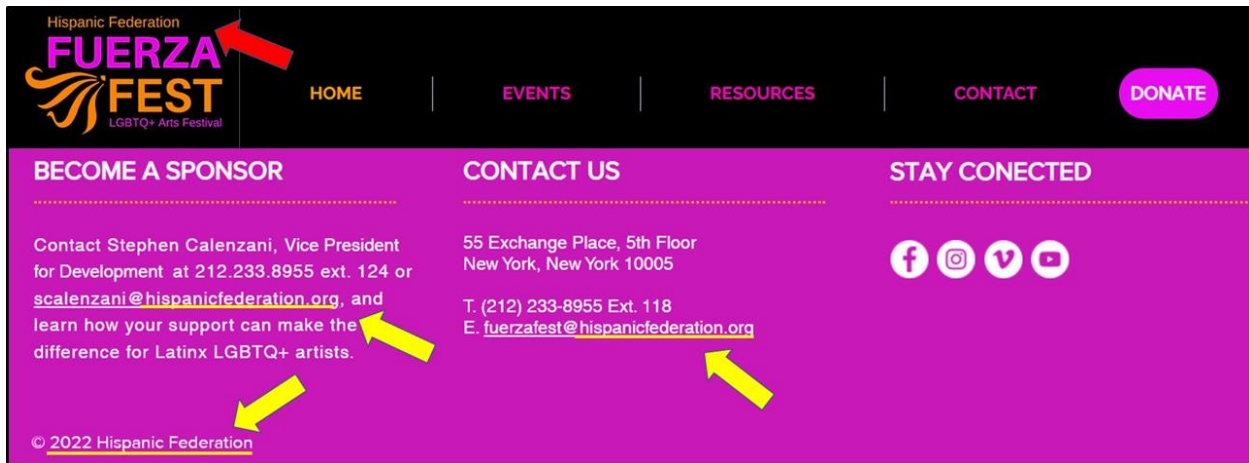

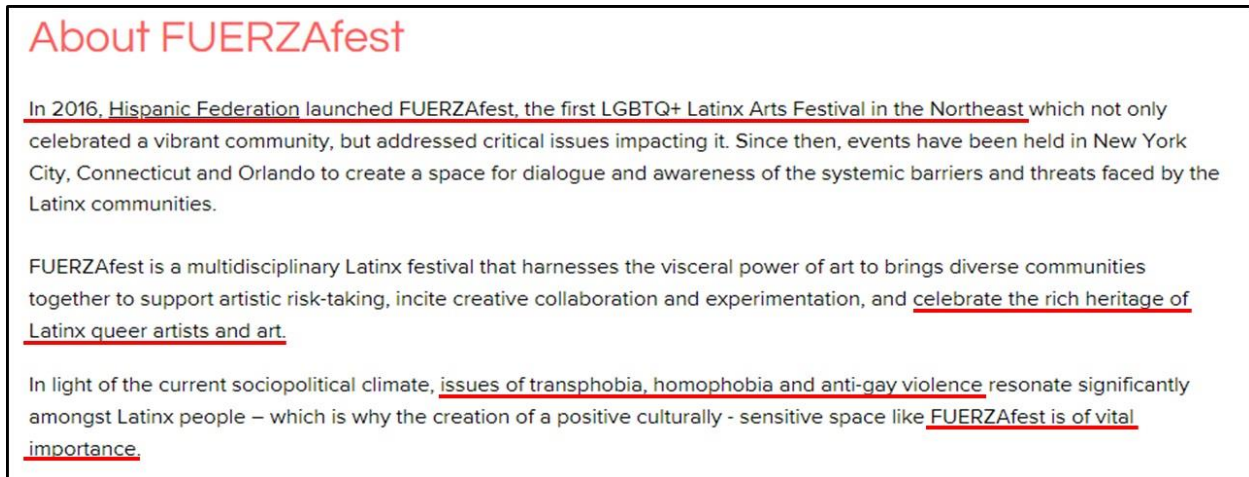

In order for an organization [to be a member of NDLON](#), the organization is required to pay dues. Organizations with an operating budget of less than \$100,000 pay \$150 in annual dues, whereas organizations with an operating budget of more than \$100,000 are required to pay \$300 in annual dues. According to [Latino Union's latest tax form 990](#), their annual expenses are well over \$100,000, meaning they pay \$300 in annual dues.

### CRITERIA:

To become an NDLON member, an applying organization should meet the following criteria:

- Be a non-profit organization.
- Work with day laborers (the workers who are employed through temp agencies are also considered part of the day labor community)
- Work on organizing and leadership development of the day labor community.
- Adopt the Mission, Vision, Principles and Resolutions which have been agreed upon at NDLON's National Conventions; among them, the policy on gender, respect for the LGBTQ community and the indigenous community.
- Participate in NDLON activities: National and regional conventions, campaigns, monthly phone call meetings of the National Coordinating Committee and others.
- Participate in the regional organizing in their area.
- Pay the annual membership dues (\$150 for organizations with an operating budget of less than \$100K and \$300 for organizations with operating budgets of more than \$100K)

Ever since the June 24 Supreme Court decision to overturn Roe v. Wade, NDLON has been on a tear, vowing to fight for abortion as a "right," and denouncing any restriction on the legalization of or access to abortion. On the same day Roe was overturned, [NDLON posted a picture](#) of a tattooed middle finger saying "F\*\*\* SCOTUS, FUND ABORTION."

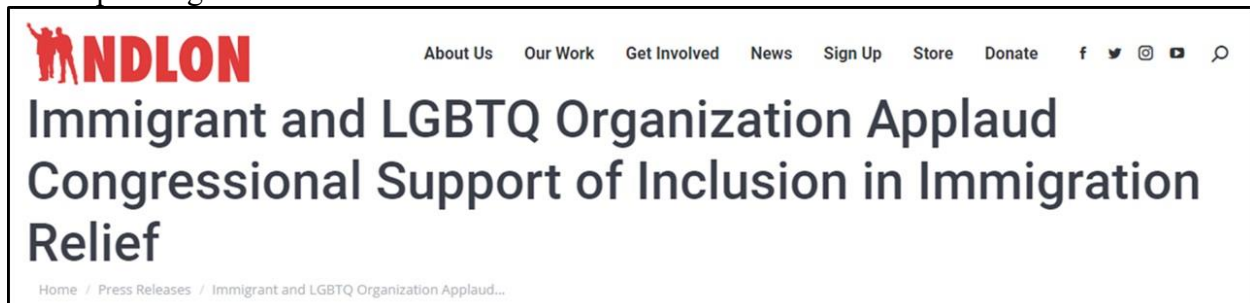

In a press release from [October 11, 2011](#), NDLO expressed its concern over LGTBQ

immigrants who might be affected by the Se Communities deportation program. The release quoted Monica Enriquez-Enriquez of Streetwise and Safe, an LGBTQ activist organization, “On this National Coming Out Day, we recognize that LGBT immigrants need more than acceptance from family, schools, and neighbors to be “out”: they need to be free from profiling, detention, and deportation.” The release celebrated “a historic confluence of movements for LGBTQ rights and migrant rights.”



Another press release published [October 1, 2014](#), advocated use of executive action to protect LGBTQ immigrants. The article criticized then-President Obama for not doing so, and quoted a spokesperson from NDLON as saying “We welcome Congressional support for the inclusion of protections for undocumented LGBTQ immigrants in executive immigration action and more voices pressing the President to act.”

All organizational affiliates of NDWA are required to pay annual dues, meaning that organizational membership in NDWA includes financial support for NDWA activism. According to [NDWA's Affiliate Manual](#), affiliates with an operating budget below \$250,000 pay \$50 every year. Affiliates whose operating budgets are between \$250,000 and \$500,000 pay \$100 every year. Affiliates with operating budgets between \$500,000 and \$1 million pay \$150 every year, and all others pay \$250 per year. In 2020, [Latino Union's operating expenses were listed at \\$723,000](#), meaning it's annual dues paid to NDWA would have been \$150.

### AFFILIATE DUES:

NDWA affiliate dues are used to support the participation of affiliates in NDWA's work - and they are an important way of sustaining our alliance together! Dues paid at any point in a given calendar year are applied to that year. For example, regardless of whether you pay in March or November or some other time in the year 2017, that payment is considered 2017 dues. Some NDWA programs (such as regrants) require you to be up to date with your dues so it's a good idea to pay as early in the year as possible. Dues are charged on a sliding scale, based on your domestic worker program budget (not your full organizational budget):

<u>Program Budget:</u>	<u>Dues:</u>
<u>Up to \$250,000</u>	<u>\$50 per year</u>
<u>\$250,000-\$500,000</u>	<u>\$100 per year</u>
<u>\$500,000-\$1,000,000</u>	<u>\$150 per year</u>
<u>Over \$1,000,000</u>	<u>\$250 per year</u>

With this in mind, there is no mistaking the fact that NDWA is a radically pro-abortion organization, which makes it impossible for any CCHD grantee to be a member. And to show that NDWA's promotion of abortion well pre-dates this grant, [NDWA tweeted in 2016](#) its solidarity with Poland in standing AGAINST abortion bans.

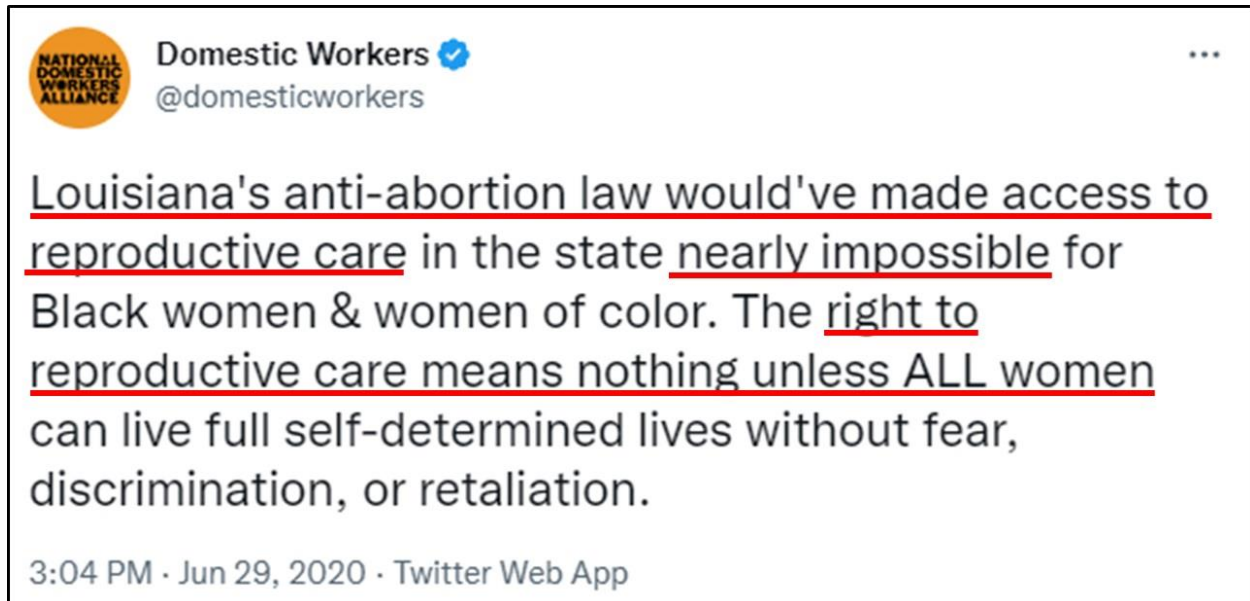

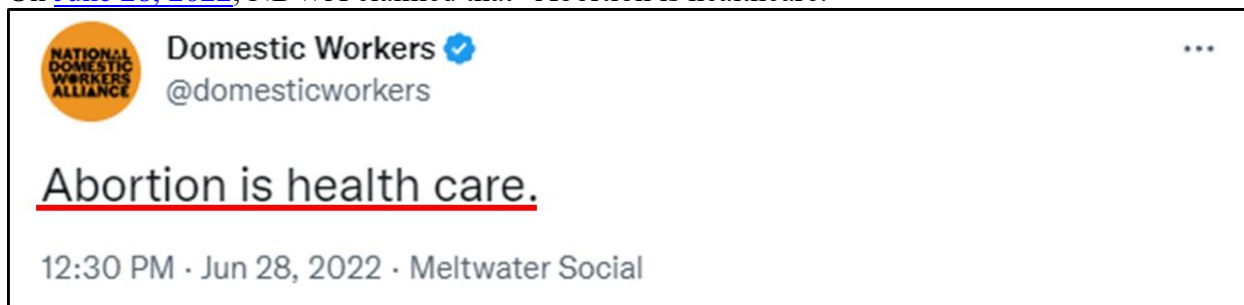

That same day, [NDWA issued a vision statement](#) regarding its entire alliance, declaring that “the domestic worker movement will continue to fight for a world where everyone has access to the full spectrum of health care, including abortion.”

Stop blocking immigrant and refugee women's access to safe abortions. Policies that deny reproductive care are a danger to immigrant and refugee women's health and safety.

### Why is this important?

Earlier this month, Jane Doe, a 17 year old refugee risked her life and crossed the border alone seeking refuge in the United States. When she arrived, immigration officials detained her against her will. She soon found out she was pregnant and decided to seek an abortion.

The Trump administration stepped in, using every tool at their disposal to force Jane to maintain an unwanted pregnancy. They subjected her to coercive religious counseling and an invasive sonogram.

A federal appeals court overturned the administration's attempts to block her access, but the fight for reproductive freedom for women like Jane is not over. Her case is part of a pattern and policy of denying abortion care to refugee and immigrant women and girls.

The man trying to control Jane's body and her future is a well-known anti-contraception and anti-abortion activist, E. Scott Lloyd, who now oversees Trump's Office of Refugee Resettlement. With no relevant experience, Lloyd is still in office and has the power to decide the fate of thousands of refugee women like Jane.

## In 2021, NDWA sign onto a letter calling for protection of access to abortion.

Today, women across the country are raising their voices to tell our leaders what we need. Together, as a movement and with a unified voice, we demand that Congress deliver on five policies women need to survive and thrive across the country, across communities and experiences, and across our lifespans:

- 1. Pass the Build Back Better Agenda:** Congress must extend the child care tax credit and guarantee 12 weeks of paid family and medical leave. We need to invest in affordable child care, universal pre-k for all families, expanded home and community-based services, better wages for care workers, and maternal health care. Additionally, we need a long-promised path to citizenship for immigrants.
- 2. Protect abortion rights and access:** Pass legislation, including the Women's Health Protection Act, to protect and expand access to abortion care regardless of where a person lives, how much money they make, or their immigration status.
- 3. Reauthorize the Violence Against Women Act:** This law is essential to protecting and supporting survivors of domestic violence and sexual assault and expanding prevention efforts.
- 4. Protect voting rights:** Voting rights are a cornerstone of our democracy and a free vote protects all other rights. Our lawmakers must protect every American from the relentless attacks on our right to vote, especially for Black, Brown, Asian American and Pacific Islander, young voters, and voters with disabilities.
- 5. Criminal legal reform:** To advance racial and gender equity and justice, we need to reimagine public safety and crisis response through investments in non-carceral, non-punitive public health solutions to community, family, and school safety. We must end mass incarceration/mass criminalization, and root out gender, racial, and disability bias from every aspect of the criminal legal system.

Women don't live our lives in silos – we need all of these policies to build a country where women and families can thrive. The President has laid out an agenda to meet the moment with us. It's up to Congress to deliver.

Our movement stands ready to work with our elected officials and champions in Congress to get this agenda passed. Even now in this moment of global crisis, especially now, the women and girls and families of our country need us to succeed and to make the united state of women strong.
